## ■ College Financial Contributions and Attendance Dues Years 9 to 13

### Financial Contributions

\$4,840 per annum or \$1,210 per term (GST exempt)

### Attendance Dues

\$1,124 per annum or \$281 per term (including GST)

Total for Years 9 to 13 = \$5,964 per annum or \$1,491 per term

Attendance Dues are approved by the Minister of Education under the terms of the Education and Training Act 2020. Special Character Contributions and Proprietor Contributions collected on behalf of the Proprietor are permitted under the terms of the Education and Training Act 2020. These contributions are eligible for taxation rebate.

An invoice will be issued every term. All Financial Contributions and Attendance Dues are payable a term in advance. The School Board reviews Financial Contributions annually. The Auckland Common Fund sets the Attendance Dues annually on behalf of the Proprietor.
